

# RLA Brushable Contact Adhesive



## **PRODUCT DESCRIPTION:**

RLA Brush Contact Adhesive is a high quality brushable grade solvent based (flammable), rapid drying contact cement, which has high strength, excellent ageing and heat resistance.

RLA Brush Contact Adhesive is designed for use on most types of vinyls, PVC skirtings/ extrusions, coverstrips, plastic and metal treads. Not recommended for exterior application.

## **FOR BONDING**

Vinyl and PVC skirtings and extrusions, coverstrips, plastic and metal treads nosings, decorative Laminates, MDF, wood and wood Veneer, paper honeycomb to steel, timber, concrete, plasterboard and most common building substrates. This adhesive has good heat resistance but like all similar adhesives can be adversely affected by plasticiser migration from PVC products

## **SURFACE PREPARATION:**

To be in accordance with the relevant Australian Standards.

Surface to be bonded must be clean, dry and free from oil, dust, loose paint and other contaminants that may affect adhesion. Highly porous substrates may require a prime coat prior to the main coat.

## **APPLICATION:**

Apply adhesive liberally with brush, roller or notched trowel.

Both bonding surfaces must be coated evenly and allowed to dry until 'touch dry'.

This will take a minimum of 5-10 minutes at 20°C.

Both surfaces should be joined within 30 minutes of application

## **SPREAD RATE:**

Up to 5-7m<sup>2</sup> per litre

Spread rates may vary depending on the condition and substrate absorbency.

## **PACKAGING:**

20 litre

## **HIGHLY FLAMMABLE:**

Avoid contact with skin and eyes and avoid breathing vapour.

## **CLEAN UP:**

To clean up equipment and adhesive spills, use Cleaner/Thinner (Flammable)

## **SHELF LIFE / STORAGE:**

Keep container tightly closed. Store Locked up.

Keep container in a cool well ventilated place away from sources of heat.

Use only non-sparking tools. Take precautionary measures against static discharges.

Avoid breathing vapours. Use only outdoors or in well ventilated areas.

Wear protective gloves, eye and face protection. Wash thoroughly after handling.

Person who are sensitive to odours and or chemicals should avoid the work area.

During the installation process, adequate ventilation of the work area should be maintained.

Do not handle until Safety Directions have been read and understood.
