### **DESCRIPTION:**

### **SURFACE PREPARATION:**

Seams must be dry and free of adhesive. Wipe the seam area with a clean cloth dampened with water. Allow the area to dry before applying ROBERTS R5601 Vinyl Seam Adhesive.
