

# QUICKSET

## LIQUID ADDITIVE



### DESCRIPTION:

**RLA QUICKSET** is a Calcium Chloride based liquid additive designed to make any cement-based product set and develop initial strength quickly.

### USES:

- To accelerate the curing of any product based on Portland Cement
- For use with RLA cement-based adhesives
- Where a fast-setting result is required, such as doorways, stairs, access ramps and repairs, shopping centres etc.
- For use in cement-based tile adhesives, grouts, screed, render or any product based on Portland Cement
- Quickset is most effective in colder temperatures (5°C to 15°C)

### SURFACE PREPARATION:

Ensure all mixing containers are clean, dry and free from excessive oil, dust, grease, wax, existing compounds, release agents, paint and any other loose contaminating materials.

### APPLICATION:

- Use Quickset to replace some of the gauging water in any Portland cement-based product
- For any 20 kg bag, use approximately 300mls as a moderate accelerator, or 1litre for a more aggressive result

#### **For Example:**

For a bag of tile adhesive that typically uses 6litres of water, use 1litre of Quickset with 5litres of water  
For faster acceleration, reduce the water content  
E.g. use 1litre of Quickset with 3.5litres of water

**IMPORTANT:** Quickset will work differently depending on the nature of the product, with actual performance only established by trialling.

Always mix a trial batch first and check the characteristics

### COVERAGE:

QUICKSET	Water	Adhesive	Set Time
300mls	5.7litres	20kg	24hours
1litre	5litres	20kg	3hours
1.5litres	4.5litres	20kg	2hours

### SHELF LIFE & STORAGE:

- 12 months when stored in original unopened packaging
- Best stored in a dry area at room temperature between 5°C and below 30°C
- Keep off cold floors and out of direct sunlight

### PACKAGING:

5litre containers

### PRECAUTIONS:

- Do not use in conjunction with metallic hardeners or reinforced concrete.
- Quickset will promote the corrosion of steel.
- Do not use it at temperatures less than 5°C.
- Quickset may significantly reduce the pot life and open time at normal and higher temperatures.
- Quickset may not be compatible with other additives.
- Always mix a trial batch first and check the characteristics
- Quickset is a strong eye irritant. Use eye protection and consult the SDS.
